

# RESOLUTION

## R231-09/10

**WHEREAS** the City of Selma invited and accepted bids during the month of May 13, 2010 through May 27, 2010 on a bid proposal on Fifteen (15) Condemned Houses (Condemned Houses 052710). Further detailed specifications were given in the Bid (Condemned Houses 052710); and

**WHEREAS** the City Clerk has complied with Sections 41-16-50 through 41-16-63 of the Code of Alabama, 1975, by advertising the bid in City Hall and further by notice to selective vendors; and

**WHEREAS** the City Clerk opened the sealed bids on May 27, 2010 and Tyus Trucking and Construction Company was the lowest responsible bidder, in the amount of Twenty Four Thousand Eight Hundred and No/100 Dollars (\$24,800.00).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SELMA AS FOLLOWS:**




